Acer SoftCapital Incorporated ("Acer Soft"), a wholly-owned subsidiary of one of the Company's controlling shareholder Acer Incorporated has entered into the conditional Share Purchase Agreement ("SPA") with Hua Nan Venture Capital Co Ltd. ("Hua Nan") on 22 January 2024, pursuant to which Acer Soft agrees to acquire, and Hua Nan agrees to sell 5,413,145 Shares representing 1.94% interest in the Company. Following the signing of the SPA, Acer Incorporated will hold in total deemed interest in 147,950,960 Shares representing 52.90% interest in the Company. In accordance with the SPA, pending actual transfers, the Shares are held by Hua Nan in trust of Acer Soft.
